We have asked for this meeting, as we need to continue to work on a business plan for economic development on the north side. This is your opportunity to address areas of concern from your business viewpoint, to hear other issues and interact from your point of view.

Did you know?

- 1) Rose Street south bound from about George Street to Livingston will be under construction again in 2010.
- 2) Minnesota DOT is reviewing plans to renovate the I-90 Bridge at Dresbach.
- 3) We have received a federal grant to have an eagle-viewing platform on Shopko Bay complete with a safe pull-off parking area.
- 4) We have over \$800,000 in the city budget to reconstruct the Northside Beach and the Park & Rec Dept. is planning to provide personnel to run Northside youth programs.
- 5) Planning sessions will be held again to address the Northside transportation needs.
